Parking & Camping Policies All events – OUTSIDE the GATES

PARKING & CAMPING POLICIES OUTSIDE the Indianapolis Motor Speedway (IMS) Gates

THE FOLLOWING POLICIES HAVE BEEN ADOPTED FOR IMS PARKING AND CAMPING AREAS OUTSIDE THE GATES TO PROVIDE A SAFE AND ENJOYABLE EXPERIENCE TO ALL FANS.

- 1. Patrons must comply with:
 - a. all federal, state, and local laws (including, but not limited to, the Indiana and Marion County health department laws, rules, and regulations) and
 - b. the IMS Code of Conduct and
 - c. VISIT <u>WWW.IMS.COM/COVID19</u>. MEASURES ARE IN PLACE TO REDUCE THE SPREAD OF COVID-19 BUT PLEASE BE ADVISED THERE ARE RISKS THAT CANNOT BE FULLY ELIMINATED. CONSIDER YOUR OWN HEALTH WHEN DECIDING WHETHER TO ASSUME THESE RISKS. IN CONSIDERATION OF THE HEALTH OF OTHERS, PLEASE STAY HOME IF YOU ARE ILL and
 - d. Camping is allowed but only in self contained units, no tent/primitive camping will be allowed over the event weekend. Self contained camping is defined as individual RV units.
 - i. Spacing standards
 - 1. Current spacing between assigned camping spots allows for ample physical distancing with 20'X40'assigned spaces
 - ii. Containment Measures
 - 1. All Infield camping has been eliminated and self-contained camping guests moved to outside lots
 - 2. Tent/Primitive Camping has been eliminated
 - 3. All campers will be advised to:
 - a. Please observe physical distancing (Distance based on current CDC/National Guidelines)
 - b. Please do not enter other camper sites unless invited and If invited, please take physical distancing measures
 - c. Please do not walk or drive through other camping locations
 - d. If you feel that others are not practicing proper physical distancing, please contact a camping lot attendant or security

2. CAMPING AREAS:

- a. Between the hours of 1:00 a.m. and the time public gates open, campers must remain in their assigned campsite.
- b. ONLY in Lot 1A and Lot 1C on August 20, 21, 22 & 23, 2020:
 - i. WRISTBANDS REQUIRED
 - 1. An RV Pass comes with 6 wristbands; a Tent Pass comes with 4 wristbands. Only the passholder can purchase up to 10 additional wristbands for \$15 per wristband through the Indianapolis Motor



Speedway Ticket Office, <u>www.ims.com</u> or at the Lot 1A or Lot 1C entrance.

2. The wristband must be worn the entire race weekend. Any person in the lot who does not have a wristband will be considered a trespasser subject to expulsion and prosecution.

3. Each patron is **REQUIRED to**:

- a. have the appropriate parking/camping pass for the area and for the vehicle (and display of that pass).
 - i. Daily parking is limited to vehicles that hold no more than 15 passengers and fit in a standard parking spot (this includes motorcycles).
 - ii. Camping requires an RV (20x40) or Tent (20x20) Pass.
 - iii. A vehicle that pulls a pull-behind or fifth wheel travel trailer does not require a separate Vehicle Pass.
 - iv. Class A and Class C RVs may purchase Vehicle Passes for up to two towed vehicles.
- b. travel at no more than 5 mph in the parking/camping lots;
- c. keep fire lanes open;
- d. keep animals on a leash and clean up after them;
- e. respect your fellow campers; and
- f. be responsible for the safety of their belongings.

4. The following is a non-exhaustive list of <u>PROHIBITED</u> items:

- a. firearms or weapons of any kind;
- b. fireworks and flares;
- c. unmanned aerial vehicles, commonly known as drones and also referred to as remotely piloted aircrafts, and similar remote controlled devices;
- d. illegal drugs, substances, or drug paraphernalia;
- e. trampolines, skateboards, pogo sticks, roller skates, and swimming pools;
- f. scaffolds and platforms;
- g. box trucks, box trailers, and trailers with golf carts;
- h. golf carts, ATVs, scooters, and mini-bikes;
- i. excessive noise (as defined by <u>Speedway Municipal Code Section 9.12</u>);
- j. selling of merchandise (e.g., tickets, food, alcohol, firewood, ice);
- k. sampling or passing out flyers;
- I. entering another customer's parking/camping spot, unless specifically invited;
- m. saving spaces (space is assigned on a "first-come, first-served" basis);
- n. dumping waste or wastewater; and
- o. any items not mentioned that may pose a safety hazard or diminish the experience of other patrons as determined by IMS.

Please note: Any of the above items are subject to change without notice and may vary for each event. Additional restrictions may be imposed in IMS's sole discretion and each patron must fully comply with all such restrictions.



- 5. IMS reserves the right to search any vehicle, RV, tent, trailer, or related accessories (collectively, "Vehicles") and to remove any Vehicle that IMS deems necessary under the circumstances.
- 6. Campfires are NOT allowed, except in appropriate elevated devices such as a fire pit or grill (do not leave unattended and properly dispose of ashes or coals).
- 7. WARNING. The area in proximity to the IMS property near and during events is subject to increased unlawful behavior. No liability is assumed by IMS (or its affiliates) for loss or damage by fire, theft, bodily injury or otherwise to you, your guests, your personal property, your belongings, personal items, or your Vehicle while on IMS property. Use of the parking/camping areas is at YOUR OWN RISK and it is your responsibility to insure for all risk of loss as you deem necessary.

Any degree of violation of these policies may result in ejection from all IMS properties.
