2021 PKNG #5 Parking & Camping Policies All events – INSIDE the GATES

PARKING & CAMPING POLICIES INSIDE the Indianapolis Motor Speedway (IMS) Gates

THE FOLLOWING POLICIES HAVE BEEN ADOPTED FOR IMS PARKING AND CAMPING AREAS INSIDE THE GATES TO PROVIDE A SAFE AND ENJOYABLE EXPERIENCE TO ALL FANS.

- 1. Patrons must comply with:
 - a. all federal, state, and local laws (including, but not limited to, the Indiana and Marion County health department laws, rules, and regulations),
 - b. the IMS Code of Conduct, and
 - c. <u>IMS Gate Regulations</u> (including, but not limited to, cooler size restrictions and other requirements for the applicable event).
- 2. **COVID-19 Protocols:** Patrons should be advised to use best practices and safety precautions, as recommended by the CDC, to prevent the spread of COVID-19 or other communicable diseases.

3. CAMPING AREAS:

- a. Between the hours of midnight and the time public gates open, campers must remain in their assigned campsite and must not enter any other part of the facility.
- b. No one may enter the gates, including to gain access to the camping area, between midnight and the time public gates open.
- c. WRISTBANDS REQUIRED ALL CAMPING AREAS and ALL EVENTS
- d. An RV Pass comes with 6 wristbands; a Tent Pass comes with 4 wristbands. Glamper wristband allocation (if any) is determined by event.
- e. The wristband must be worn at all times. Any camper who does not have a wristband will be considered a trespasser subject to expulsion and prosecution.

4. All patrons are REQUIRED to:

- a. Have the appropriate parking/camping pass for the area and for the vehicle (and display of that pass).
 - i. Daily parking is limited to vehicles that hold no more than 15 passengers and fit in a standard parking spot (this includes motorcycles).
 - ii. Camping requires a RV (20x40) or Tent (20x20) Pass.
 - iii. A vehicle that pulls a pull-behind or fifth wheel travel trailer does not require a separate Vehicle Pass.
 - iv. Class A and Class C RVs may purchase Vehicle Passes for up to two towed vehicles.
- b. travel at no more than 5 mph in the parking/camping areas;
- c. keep fire lanes open;
- d. respect your fellow campers; and
- e. be responsible for the safety of their belongings.



5. IMS Gate Regulations apply, without limitation, the following items are <u>PROHIBITED</u> and MAY NOT be left around any Admission Gates:

- Weapons of any type, including pocketknives, firearms and ammunition;
- Fireworks and flares;
- Flagpoles;
- Unmanned aerial vehicles, commonly known as drones and also referred to as remotely piloted aircrafts, and similar remote controlled devices;
- Selfie sticks;
- Animals (except service animals providing assistance to an individual with a disability);
- Lasers of any kind;
- Golf carts, ATVs, , minibikes, and scooters;
- Coolers larger than 18" x 14" x 14" (except in authorized parking/camping locations). <u>No</u> coolers of any size are allowed into concert areas, unless expressly authorized by <u>IMS in advance of the event</u>;
- Glass containers;
- Stickers;
- Scaffolding or platforms;
- Illegal drugs and substances or drug paraphernalia;
- Sampling or flyers of any kind;
- Aerosol cans;
- Bicycles;
- Carts and wagons (Indy 500 Race Day only);
- Items restricted by local, state or federal law;
- Offensive or obscene materials (e.g., flags, signs, clothing);
- Roller blades, skateboards, skates, pogo sticks, hover boards and scooters;
- Soliciting of any kind;
- Trampolines and swimming pools;
- Any other items not mentioned that may pose a safety hazard or diminish the enjoyment of the event by other guests may be refused at the discretion of security and management.

Please note: Any of the above items are subject to change without notice and may vary for each event. Additional restrictions may be imposed in IMS's sole discretion and each patron must fully comply with all such restrictions.

- 6. IMS reserves the right to search any vehicle, RV, tent, trailer, or related accessories (collectively, "Vehicles") and to remove any Vehicles that IMS deems necessary under the circumstances.
- 7. Campfires are NOT allowed inside IMS Gates.
- 8. WARNING. The area in proximity to IMS property near and during events is subject to increased unlawful behavior. No liability is assumed by IMS (or its affiliates) for loss or damage by fire, theft, bodily injury or otherwise to you, your guests, your personal property,



your belongings, personal items, or your Vehicle while on IMS property including if caused by the negligence of released parties. Use of the parking/camping areas is at YOUR OWN RISK and it is your responsibility to insure for all risk of loss as you deem necessary. Without limitation, the risks assumed and claims released include all risks and claims associated with COVID-19. You agree that we may disclose your personal information to authorities for contact tracing.

Any degree of violation of these policies may result in ejection from all IMS properties.
