EMPLOYEE EXPECTATIONS

- Present a friendly and welcoming environment for Know your surroundings all guests
- Focus on alleviating any potential anxiety related to parking, camping and traffic direction
- Understand every lot pass and the differences between them
- Understand the importance of checking lot passes at each entrance
- Strict enforcement of lot control procedures in a kind manner
- Ensure all processes are performed in a consistent manner to allow for a consistent experience
- Know the location/direction/striping of each lot
- Know the specifics of all lot operations and traffic flow
- Know how to assist guests with disabilities

- Understand the Color Zones and the nearest open pedestrian gates
- Follow directives from Pagoda Command
- Ensure incident reports are filled out immediately following an incident
- Report all issues and/or concerns to your Supervisor
- Ensure all processes are performed in a consistent manner to allow for a consistent experience
- Utilize daily briefing sheets
- Ask Supervisors or Pagoda Command if you do not know the answer to a question



WORKING IN TRAFFIC IN OUTSIDE LOTS

Outside Lots Traffic Direction Do's:

- Extend your arms and make exaggerated hand and arm movements.
- To stop traffic, do so with handheld out and arm extended away from your body with palm facing the traffic.
- Give clear instructions using hands and arms held away from your body, waving and pointing in the direction you want traffic to flow.
- Be aware of both vehicle and pedestrian traffic.
- Give priority to emergency vehicles.
- Listen closely to radio transmissions. Changes in traffic pattern or for a specific vehicle may be relayed via radio.
- Be aware of all credentialed parking stickers and refer them to their proper parking areas.
- Be aware of traffic coming from all directions.
 - Constantly look around.
 - Never assume you know what is behind you.

- Be aware of your current situation at all times.
- Watch traffic for pedestrians who may be otherwise occupied.
- Smile and be polite.

Outside Lots Traffic Direction Don'ts:

- Stand still, remember to move around to allow for proper awareness from different directions
- Point with your finger when directing traffic
- Allow vehicles to stop and clog up intersections or pathways for vehicles
- Hold up traffic by speaking to individuals in vehicles for too long or more often than needed
- Walk away from your post without notifying your Supervisor and waiting for your replacement



PARKING & CAMPING OPTIONS

- Free Public Parking offered in a few limited areas on a first-come, first-served basis
- Paid Automobile Parking sold in 3-day or Race Day only permits
- Tent Camping sold on a 2-day or 4-day basis
- Allows for a 20' x 20' space in a lot that must fit both a tent and the vehicle driven into the lot. No spaces are reserved.
- RV Camping sold on a 4-days basis
- Allows for a 20' x 40' space that must fit the driven RV or the truck and pull behind trailer.
- Disabled Parking –Daily parking areas have designated areas for customers with state issued disabled hangtags, placards or license plates. These spaces are very limited and assigned on a first-come first-served basis



PARKING & CAMPING OPTIONS

Tent Camping (with or without a vehicle) – 20' X 20' space

- One vehicle allowed
- These passes may be purchased in Lots 1A, 1C, 2, 3 Grass and Lot 4. NOTE: All
 options are sold out for Indianapolis 500.

RV Camping (with or without a towed vehicle) – 20' X 40' space.

- Any trailer pulled behind a vehicle (including 5th Wheel Campers) is required to purchase an RV pass only.
- Both Class-A and Class-C motorhomes also require an RV pass. Examples are pictured on the next slide. No additional auto pass is needed for vehicles towing trailers of any kind.
- These passes may be purchased in Lots 1A, 1C, 2, 3 Grass, 3 Pavement, 4, 4AP and 6. Towed Autos, Trailers or Motorcycles
- Any vehicle pulled behind a motor coach or Class-C motorhome.
- These passes may be purchased in Lots 1A, 1C, 2, 3 Grass, 3 Pavement, 4, 4AP and 6.




LOT SPECIFICATIONS

- RV spaces are approximately 20' X 40'
- Premium RV spaces are approximately 20' X 50' (only Lot 4AP)
- Tent spaces are approximately 20' X 20'
- Daily Vehicle spaces are approximately 10' X 20'

LOT LOCATIONS - NORTH (RED) ZONE

- Lot 1A: northwest of the intersection at Georgetown Rd. and 25th St. The entrance to this lot is on Georgetown Rd. just north of 25th St. across from Lot 4 (same drive as the Coke Facility).
 - Specific Lot Policies
 - MUST have a Yellow wristband for entry during Race Weekend
 - Daily Parking is not permitted.
 - Any tow vehicles must be parked on the same space as the accompanying RV. If any tow vehicles do not fit, the Lot Supervisor may designate a special area for their parking.
 - Hours of Operation: 7am Thursday 12pm day after the race (24 hours)
 - Amenities: dry camping, shower trailers (Race Weekend only)
 - Surface: Grass
- Lot 1B: Georgetown Rd just south of 30th St, the entrance to the lot is across from Gate 9A.

- Specific Lot Policies
 - No overnight parking or camping is permitted. Daily parking only.
 - Surface: Grass
 - Hours of Operation: One hour before public gates open May 26th and 28th
- Lot 1C: 30th St. west of Georgetown Rd., the entrance to this lot is the second drive after the creek.
 - Specific Lot Policies
 - MUST have a Teal wristband for entry.
 - Tent campers will be directed to areas designated for tents only.
 - RV campers will be directed to areas designated for RVS only.
 - Amenities: dry camping
 - Surface: Grass
 - Hours of Operation
 - Camping: 7am Thursday 12pm day after the race (24 hours)



LOT LOCATIONS - NORTH (RED) ZONE

- Lot 4: northeast of the intersection of 25th Street and Georgetown Road. The entrance to this lot is the same as for the house that sits on this property. The entrance further north on Georgetown Road is closed.
 - Specific Lot Policies
 - Daily parking is not permitted in this lot
 - No box trucks or box trailers are permitted in the lot.
 - Tents may be directed to areas designated for tents only.
 - This is a family-oriented lot. Rowdy behavior or disruption to other campsites results in removal from the lot.
 - Any tow vehicle must be parked on the same space as the accompanying RV. If any tow vehicle does not fit, the Lot Supervisor may designate a special area for their parking.
 - Amenities: 30amp & 50amp hookups are available
 - Surface: Grass
 - Hours of Operation
 - Camping: 7am Thursday 12pm day after the race (24 hours)
 - No Daily Parking

- **Lot 4A Premium**: Georgetown Road just north of Gate 9A to enter the facility. The entrance to this lot is directly across from the south end of Lot 1B
 - Specific Lot Policies
 - Daily/tent parking is not permitted in this lot.
 - The dump station and water are provided for the convenience of 4AP patrons only.
 - No stakes shall be driven into the ground.
 - Any tow vehicle must be parked on the same space as the accompanying vehicle. If any tow vehicle does not fit, the Lot Supervisor may designate a special area for their parking.
 - Amenities: 30amp & 50amp hookups are available
 - Surface: Crushed Stone
 - Hours of Operation
 - Camping: 7am Thursday 12pm day after the race (24 hours)
 - No Daily Parking



LOT LOCATIONS - WEST (GREEN) ZONE

 Lot 2: Georgetown Rd. across from Gate 6. The entrances are an extension of 20th Street and can be reached via Auburn Street or off of Georgetown Road (non-Race Days).

- Specific Lot Policies
 - No box trucks or box trailers are permitted in the lot.
 - Tent campers may be directed to areas designated for tents only.
 - Any tow vehicles must be parked on the same space as the accompanying RV. If any tow vehicle does not fit, the Lot Supervisor may designate a special area for their parking.
 - Amenities: dry camping, shower trailers (Race Weekend only)
 - Surface: Grass
 - Hours of Operation
 - Race Weekend Camping: 7am Thursday 12pm day after the race (24 hours)
 - Daily Parking: One hour before public gate times May 12-13, 19-21, and 26, 28

- Lot 6: Meyers Drive. Meyers Drive is a north/south street easily accessible from 25th Street near Georgetown Road. The entrance to this lot is at the south end of Meyers Drive.
 - Specific Lot Policies
 - Daily/tent parking is not permitted in this lot.
 - The dump station and water are provided for the convenience of Lot 6 patrons only.
 - No stakes shall be driven into the ground.
 - Any tow vehicle must be parked on the same space as the accompanying vehicle. If any tow vehicle does not fit, the Lot Supervisor may designate a special area for their parking.
 - Amenities: 30amp & 50amp hookups are available
 - Surface: Grass
 - Hours of Operation
 - Camping: 7am Thursday 12pm day after the race (24 hours)
 - No Daily Parking



LOT LOCATIONS - WEST (GREEN) ZONE

- Lot 5: Georgetown Rd. across from Gate 5A. The lot is situated in the middle of the mobile home park on the west side of Georgetown Rd. Entrances are located off Georgetown Rd. and on the west side of the Lot (open Race Day only).
 - Specific Lot Policies
 - No box trucks or box trailers are permitted in the lot.
 - Tent campers may be directed to areas designated for tents only.
 - Any tow vehicles must be parked on the same space as the accompanying RV. If any tow vehicle does not fit, the Lot Supervisor may designate a special area for their parking.
 - Amenities: dry camping, shower trailers (Race Weekend only)
 - Surface: Pavement
 - Hours of Operation
 - Camping: 7am Thursday 12pm day after the race (24 hours)

- Lot 6A: Georgetown Rd. just north of Gate 6. Formerly known as the Diller Lot, entrance is on the west side of Georgetown Rd just north of Lot 9.
 - Specific Lot Policies
 - No box trucks or box trailers are permitted in the lot.
 - Tent campers may be directed to areas designated for tents only.
 - Any tow vehicles must be parked on the same space as the accompanying RV. If any tow vehicle does not fit, the Lot Supervisor may designate a special area for their parking.
 - Amenities: dry camping, shower trailers (Race Weekend only)
 - Surface: Grass
 - Hours of Operation
 - Daily Parking: One hour before public gate times May 26th and 28th



LOT LOCATIONS - WEST (GREEN) ZONE

- Lot 9: Georgetown Rd. on the west side across from Gate 6. Entrance is off Georgetown Rd. just north of Lot 2 entrance.
 - Specific Lot Policies
 - No box trucks or box trailers are permitted in the lot.
 - Tent campers may be directed to areas designated for tents only.
 - Any tow vehicles must be parked on the same space as the accompanying RV. If any tow vehicle does not fit, the Lot Supervisor may designate a special area for their parking.
 - Amenities: dry camping, shower trailers (Race Weekend only)
 - Surface: Pavement

- Hours of Operation
 - Camping: 7am Thursday 12pm day after the race (24 hours)
- Gate 1 Parking: Crawfordsville Rd. west of Gate 1. Entrance is off Crawfordsville Rd northwest of the roundabout. Only accessible from the west-bound side of the road.
 - Specific Lot Policies
 - No overnight parking or camping is permitted. Daily parking only.
 - Surface: Pavement
 - Hours of Operation: One hour before public gate opening May 13, 19-21, 26, and 28



LOT LOCATIONS - SOUTH (ORANGE) ZONE

- Main Gate East & West: corner of 16th Street and Polco Street, the main entrance to each lot can be found on the east and west side of Polco Street respectively.
 - Specific Lot Policies
 - No overnight parking or camping is permitted. Daily parking only.
 - Surface: Gravel
 - Hours of Operation
 - Parking: One hour before public gates open May 12-13, 19-21, 26, 27, 28
- Lot 3 Grass: 16th Street to the east of the Brickyard Plaza Shopping Center. The entrance to this lot if off of 16th Street at the main entrance to the Brickyard Plaza Shopping Center across from Gate 3. The 16th Street entry to the grass lot is only used for exit after the race.
 - Specific Lot Policies
 - No box trucks or box trailers are permitted in the lot.
 - Tent campers may be directed to areas designated for tents only.
 - Any tow vehicles must be parked on the same space as the accompanying RV. If any tow vehicle does not fit, the Lot Supervisor may designate a special area for their parking.
 - Amenities: dry camping
 - Surface: Grass

- Hours of Operation
 - Camping: 7am Thursday 12pm day after the race (24 hours)
 - Daily Parking: One hour before public gate times May 26 and 28
- Lot 3 Pavement: 16th Street and is also known as the Brickyard Plaza Shopping Center. The entrance for this lot is the main entrance to the plaza across from Gate 3.
 - Specific Lot Polices
 - No box trucks or box trailers are permitted in the lot.
 - No throwing Frisbees, footballs, baseballs or other games is permitted on the pavement.
 - No skateboards or roller skates are permitted on the pavement.
 - No stakes are permitted to be driven in to the pavement.
 - Only one extra vehicle is allowed per RV pass and it if and the RV cannot be parked on the same area, the Lot Supervisor may designate a special area for parking any extra vehicles.
 - Amenities: 30amp & 50amp hookups are available
 - Surface: Asphalt
 - Hours of Operation
 - Camping: 7am Thursday 12pm day after the race (24 hours)
 - Daily Parking: One hour before public gate times May 12-13, 19-21, 26, 27, and 28



GENERATOR PASS PROCEDURE

• Generator passes are sold in advance to some guests in the following lots:

- Lot 3P
- Lot 4
- Lot 4AP
- Lot 5
- Lot 6
- Placement of generators available within the lots is pre-determined with the Lot Supervisor. The generators are setup prior to Thursday at 7AM and hook ups are coordinated with United Rentals.
- The number of presold tickets is provided to each lot. These spots are reserved and should only be given to people who present a pre-paid ticket. All camping spaces are pre-sold and only those with pre-paid are allowed access.



LOT SECURITY

Wristbands Required – Lot 1A & Lot 1C

- Each tent space will receive four wristbands; each RV space will receive six wristbands.
- Guests can purchase an additional 10 wristbands for \$15/wristband through the Indianapolis Motor Speedway Ticket Office, www.ims.com or at the Lot 1C entrance. Guests may only purchase additional if they purchased the parking pass.
- All Lot 1A and Lot 1C guests must wear their wristband for the entire race weekend.
- Any person in the lot who does not have a wristband will be considered a trespasser subject to expulsion and prosecution.

Curfew – All outside lots

All campers must be in their own campsites by 1:00 a.m.




LOT 1C

Striped Parking Plan – Lot 1C

- The tent and RV areas will employ a striped parking plan and guests will be guided to parking spots with the help of police officers and Safety Patrol employees using ATVs. Guests will be parked according to their arrival, so groups looking to park together MUST arrive at the same time.
- There will be separate parking sections for RVs and cars. Therefore, if groups come in an RV and a car, they will not be able to park together. RVs with towed vehicles,

however, are allowed.





IMS CAMING POLICY

- Patrons must comply with:
 - all federal, state, and local laws (including, but not limited to, the Indiana and Marion County health department laws, rules, and regulations)
 - the IMS Code of Conduct.
- CAMPING AREAS
 - Between the hours of 1:00 a.m. and the time public gates open, campers must remain in their assigned campsite.
 - ONLY in Lot 1A and Lot 1C on May 25-28
 - WRISTBANDS REQUIRED 1. An RV Pass comes with 6 wristbands; a Tent Pass comes with 4 wristbands. Only the passholder can purchase up to 10 additional wristbands for \$15 per wristband through the Indianapolis Motor Speedway Ticket Office, www.ims.com or at the Lot 1A or Lot 1C entrance.
 - The wristband must be worn the entire race weekend. Any person in the lot who does not have a wristband will be considered a trespasser subject to expulsion and prosecution.

- Each patron is REQUIRED to:
 - have the appropriate parking/camping pass for the area and for the vehicle (and display of that pass).
 - Daily parking is limited to vehicles that hold no more than 15 passengers and fit in a standard parking spot (this includes motorcycles).
 - Camping requires an RV (20x40) or Tent (20x20) Pass.
 - A vehicle that pulls a pull-behind or fifth wheel travel trailer does not require a separate Vehicle Pass.
 - Class A and Class C RVs may purchase Vehicle Passes for up to two towed vehicles.
 - Travel at no more than 5 mph in the parking/camping lots;
 - Keep fire lanes open
 - Keep animals on a leash and clean up after them
 - Respect your fellow campers
 - Be responsible for the safety of their belongings



IMS CAMPING PROHIBITED ITEMS

- The following is a non-exhaustive list of PROHIBITED items
 - Firearms or weapons of any kind
 - Fireworks and flares
 - Unmanned aerial vehicles, commonly known as drones and also referred to as remotely piloted aircrafts, and similar remote-controlled devices
 - Illegal drugs, substances, or drug paraphernalia
 - Trampolines, skateboards, pogo sticks, roller skates, and swimming pools
 - Scaffolds and platforms
 - Box trucks, box trailers, and trailers with golf carts
 - Golf carts, ATVs, scooters, and mini-bikes

- Excessive noise (as defined by Speedway Municipal Code Section 9.12)
- Selling of merchandise (e.g., tickets, food, alcohol, firewood, ice)
- Sampling or passing out flyers
- Entering another customer's parking/camping spot, unless specifically invited
- Saving spaces (space is assigned on a "first-come, first-served" basis)
- Dumping waste or wastewater
- Any items not mentioned that may pose a safety hazard or diminish the experience of other patrons as determined by IMS.



PARKING PROCEDURES

- The process of parking automobiles in the outside lots is done to maximize the amount of space used in the lot. Outside lots are pre-sold to capacity ahead of the events in many cases.
- Camping spaces are allocated on a first-come, first-served basis in each camping lot. Lot 1C, Lot 2 and Lot 3 escort RVs to the open spaces, as needed.
- Lot 1C is large and will rely on traffic direction for the guests to the stalled spaces in the lot.
