OBJECTIVE

The objective of the Non-Profit Fundraising Program is to combine our track staffing needs with community initiatives at the Indianapolis Motor Speedway (IMS). The goal is to build strong, mutually beneficial relationships with local organizations during our marquee events hosted at IMS. When your Group participates with IMS, not only are you contributing to the success of some of the world's largest sporting events, but your organization will receive a significant donation in a short amount of time.

Our fundraising groups are crucial to our success, and in exchange for donating to your organization, we expect the following from each of your volunteers:

ON-SITE DURING EVENTS:

- Arrive to check in on-time and communicate any tardiness to group leader or IMS Staff as soon as possible.
- Treat fellow employees, customers and clients respectfully, apropriately and professionally at all times.
- Demonstrate commitment to your job responsibilities and providing superior guest service throughout your shift.
- Follow the guidance and direction of supervisors.
- Refrain from smoking, unless during a break in a designated break area. Absolutely no smoking at your post or within the sight of guests while in uniform.

WHEN YOU FUNDRAISE WITH THE GUEST EXPERIENCE DEPARTMENT, YOUR GROUP WOULD SUPPORT OUR FANS IN ONE OF THE FOLLOWING AREAS: WORKING AS AN USHER IN OUR STANDS AND MOUNDS, SCANNING TICKETS AT A GATE, OR PARKING CARS IN AN OUTSIDE LOT.

1. WHAT ARE THE GROUP REQUIREMENTS?

To participate in our fundraising your group must classify as a 501c3 organization in order that we may make a charitable contribution to your organization.

2. IS THERE AN AGE LIMIT FOR ANYONE PARTICIPATING?

We do ask that fundraisers be at least 16 years old and for every three (3) minors (under 18) we do require one (1) adult (21 and older). All minors do need to fill out a minor waiver form that asks for guardian permission to participate.

3. ABOUT HOW MANY PEOPLE SHOULD WE ATTEMPT TO GATHER TO MAKE THIS SUCCESSFUL? IS THERE A MAX NUMBER OF PARTICIPANTS?

We have a minimum of 5 people needed per group, but the more the merrier. We do not have a cap amount for groups however when a group says they have more than 50 fundraisers participating, we will discuss a plan to where your group will be placed. The odds are that with that number, we will likely need to split you up to different areas around the track (however we try to keep each group as close to one another as possible). We pay each group per person, per day. For example, on Indy 500 day (May 26), we will pay your group \$120 per person. So, if you bring 50 people, we will pay your group \$6,000. We also have opportunities for bonuses so you can make even more money!



4. DO YOU KNOW WHAT DATES MAY BE AVAILABLE FOR US?

5. WOULD WE HAVE TO COMMIT TO MULTIPLE DATES?

You do not need to come out on more than one day in order to earn a donation for your organization. We do strongly suggest that all groups, if they only have availability for one day, prioritize working Indy 500 Race Day. This is the day that your group could earn the most amount of money and it is the day we have the biggest need. Additionally, if you sign-up to work more than one day, there is a chance your group could earn additional bonuses.



6. IS THERE ANYTHING A VOLUNTEER WOULD NEED TO BRING WITH THEM THE DAY OF HE EVENT?

We provide groups with sunscreen, water, and ice, but we highly encourage that you bring your own sunscreen if you do not like thick sunscreen. Lastly, it never hurts to bring your own reusable water bottles. You can either bring food and snacks or bring money for concession stands but you will need one or the other because you will not be able to leave the property for lunch. We will also give each group member a t-shirt and a hat to wear, we ask that you wear comfortable close-toed shoes to stand in for long periods of time and preferably wear black shorts or pants.

FOR GROUPS WHO FUNDRAISE ON BOTH I500 AND CARB DAY (MAY 24, 2024):

Bonus Opportunity 2

If a group signs up for BOTH Carb Day and I500 Race Day, they will get an additional \$600 (an additional 5 people's worth of money).

BOTH BONUS OPPORTUNITIES ARE CONTINGENT UPON THE GROUP BRINGING WITHIN 10% OF PREVIOUSLY STATED GROUP NUMBERS.

All of these opportunities mean that if your group brings 40 people on Carb Day and 40 people on Indy 500 day, your group will make \$4,000 on Carb Day, \$4,800 on I500 Day, plus \$600 for working both days, plus \$1,200 for showing up on I500 Day with the number of people you said you would bring. That is a total of \$10,600 in just two days!!

WHEN YOU FUNDRAISE WITH THE FACILITIES DEPARTMENT, YOUR GROUP WOULD SUPPORT OUR HOUSEKEEPING INITIATIVES IN VARIOUS AREAS/SECTIONS THROUGHOUT THE INDIANAPOLIS MOTOR SPEEDWAY DURING PUBLIC EVENT DAYS AND POST-RACE CLEANUP.

1. WHAT IS THE ECOLOGY PROGRAM?

When you fundraise with the Facilities Department, your group would support our housekeeping initiatives in various areas/sections throughout the Indianapolis Motor Speedway during public event days and post-race cleanup. Responsibilities include:

- Ensure the grounds and restrooms are maintained, stocked, and cleaned.
- Empty and reline recycling and waste receptacles.
- Transport debris, recycling, and waste to compactors and/or dumpsters.
- Remove debris, recycling, and waste from grandstands and parking lots.

2. WHAT ARE THE GROUP AND PARTICIPANT REQUIREMENTS?

To participate, your group must classify as a 501c3 organization, so our Accounting Department can issue a check directly to the organization. Participants must be at least 16 years old or older. All participants under 18 years of age must have a parental permission Consent, Indemnification, & Liability Release Waiver signed and notarized before participating. The number of participants required depends on: (a) the day(s) the group participates and (b) the area(s)/section(s) available. For example, the bigger the area(s)/section(s), the more required participants are needed.



3. WOULD WE HAVE TO COMMIT TO MULTIPLE DATES?

You would not need to participate more than one date. We do advise against participating at the Indianapolis 500 if your group plans on participating in Post-Race Cleanup. A group is welcome to participate as much as they want but will need to make sure the required number of female and male participants is satisfied for each commitment though.

5. WHAT ARE THE BONUS INCENTIVES FOR THIS YEAR?

Bonus Opportunity 1

If a group signs up for Grand Prix Race Day (May 11), Qualifications (May 18 <u>or</u> 19), <u>AND</u> Indy500 Race Day (May 26) they will be eligible for a \$1,000 bonus.

Bonus Opportunity 2

If a group signs up for Indy500 Race Day (May 26), one (1) date during Brickyard weekend (July 20 <u>or</u> 21), AND one (1) date during IMSA weekend (September 21 <u>or</u> 22) they will be eligible for a \$750 bonus.

BOTH BONUS OPPORTUNITIES ARE CONTINGENT ON FULFILLING ALL THE RESPONSIBILITIES OUTLINED WITHIN THE ECOLOGY PROGRAM HANDBOOKS AND THE ECOLOGY PROGRAM SERVICE AGREEMENTS (EXECUTED).

FOOD & BEVERAGE - ARAMARK NONPROFIT FUNDRAISING FAQ

ARAMARK, THE SOLE CONCESSIONAIRE OF INDIANAPOLIS MOTOR SPEEDWAY, IS OFFERING FUNDRAISING OPPORTUNITIES FOR NON-PROFIT ORGANIZATIONS FOR THE 2024 SEASON. LOCAL 501C3 GROUPS HAVE THE OPPORTUNITY TO OPERATE A DESIGNATED CONCESSION STAND ON EVENT DAYS AND SHARE IN THE PROFITS GENERATED DURING THE EVENT. THE REQUIREMENTS ARE SIMPLE AND THE COMMITMENT IS WORTHWHILE.

1. WHAT ARE THE GROUP REQUIREMENTS?

- Group that is classified as a 501c3 organization.
- IRS Tax-Exempt Status Documentation
- Certificate of Liability Insurance for \$1 million coverage (If needed, Aramark has umbrella coverage as an option at no cost)
- SOR Background Check
- Completed W9
- Signed Contract
- Training attendance by Group Lead

2. IS THERE AN AGE LIMIT FOR ANYONE PARTICIPATING?

Volunteers must be at least 16 years old and for every three (3) minors (under 18) we do require one (1) adult (18 and older).

3. ABOUT HOW MANY PEOPLE SHOULD WE ATTEMPT TO GATHER TO MAKE THIS SUCCESSFUL? IS THERE A MAX NUMBER OF PARTICIPANTS?

You will need to have a minimum of 4 people per group, but the more the merrier. We do not have a cap amount for groups.



4. HOW DOES MY GROUP EARN A DONATION?

The groups are paid a percentage of the sales for food and beverage in the concession stand they operate while also having the opportunity to collect gratuities. There may also be circumstances for groups to earn a per volunteer day rate.

5. WOULD WE HAVE TO COMMIT TO MULTIPLE DATES?

You do not need to come out on more than one day, I suggest that if you have availability only for one day, that you join us on I500 Race Day because it's the day you'd make the most amount of money and is also our highest priority day.

WHEN YOU FUNDRAISE WITH LEGENDS GLOABAL MERCHANDISE, YOUR GROUP WOULD COME OUT AND WORK IN ONE OF THE FOLLOWING TYPES OF STORES: TENTS, WALK-INS, TRAILERS, SINGLE BLOCKS, DOUBLE BLOCKS, PROGRAM STANDS, OR SMALL BARNS TO SELL MERCHANDISE.

1. WHAT ARE THE GROUP REQUIREMENTS?

To participate in our fundraising, your group must classify as a 501c3 organization so that our accounting department can write a check directly to the organization. Your group will need to provide a valid Certificate of Insurance, a Tax Exemption form, along with a W-9.

2. IS THERE AN AGE LIMIT FOR ANYONE PARTICIPATING?

We do ask that fundraisers are at least 18 years or older. No minors are allowed to fundraise with Legends Global Merchandise.

3. ABOUT HOW MANY PEOPLE SHOULD WE ATTEMPT TO GATHER TO MAKE THIS SUCCESSFUL? IS THERE A MAX NUMBER OF PARTICIPANTS?

We have a minimum of 2 people needed in our smaller stands. Additionally, the minimum in our larger stores are about 8-10 fundraisers. The number of minimum fundraisers depends on the type of store your group fundraises in. We do not have a maximum number of fundraisers, but group leaders are responsible for making sure that the minimum number of volunteers are always in the store.

5. WOULD WE HAVE TO COMMIT TO MULTIPLE DATES?

We only have a few store locations that are open race day only. Most of our locations are open multiple days throughout May. Commitments vary from store to store. We have a variety of opportunities available.

6. IS THERE ANYTHING A WORKER WOULD NEED TO BRING WITH THEM THE DAY OF THE EVENT? (FOOD, WATER, MONEY FOR CONCESSIONS, ETC).

We do not provide food, water, or money for concessions to any of our group members or employees. We do allow groups to bring coolers (that follow track guidelines). You can either bring food and snacks or bring money for concession stands, but you will need one or the other because you will not be able to leave the property for lunch. We will give each group member a polo to wear, we ask that you wear comfortable close-toed shoes to stand in for long periods of time and preferably wear khaki (material) shorts or pants.
